1. Call to Order

At 3:00 p.m. Chairman Grim called the meeting to order. Chairman Grim noted that an Executive Session was held and no action was taken.

2. Pledge of Allegiance

The Pledge of Allegiance was recited by those in attendance.

3. Roll Call of Council Members

Attendance was taken at the direction of Chairman Grim which established that a quorum of the Council was present.

Mr. Guido Pichini mentioned the passing of Mr. Richard Orwig, who was very active in the KU community as a trustee member and chair for many years.

4. Remarks by Mr. Robert Grim, Council Chairperson

Mr. Grim welcomed everyone to the first public session of the KU Council of Trustees of 2024 and hoped everyone had a relaxing Spring Break and are geared up for the home stretch of the academic year.

He expressed, as the advocacy season progresses, we will continue to highlight how Kutztown University and PASSHE universities are meeting workforce needs; increasing access and enrollment; driving affordability; supporting student success; and pursuing financial sustainability. The State System is requesting state funding of \$623.7 million — a \$38 million or 6.5% increase over the current fiscal year. The increase would enable PASSHE's Board of Governors to freeze tuition again next year. Anything we receive above and beyond the 6.5% increase would be put to good use to further reduce costs to students, support student success, and expand student opportunities.

Mr. Grim continued, to do this, we are coordinating across the system to pitch and push success stories in both traditional and social media to support the one-on-one conversations President Hawkinson, our Government Relations staff and others have with legislators about our budget request.

5. Remarks by Mr. Gavin Stone, Student Government Board President

Mr. Stone shared SGB has made great progress in fulfilling their goals for this semester. They continue to focus on student safety on/off campus. There were multiple instances where SGB was needed to address concerns to the student body regarding residence hall, safety, dining services, library services, and the new MyKU. He is willing to go into further detail as needed. After input from the SGB budget and finance committee, they raised the student activity fee by \$5.00 hoping the small change would give clubs extra funding but still keep us as one of the lowest activity fee schools in the PASSHE system. The final review with the KUSSI Board of Directors is on March 25th. SGB is focusing on two primary agendas. One is to increase student involvement across campus while focusing on student mental health and wellbeing. Ten SGB members attended the Board of Student Government President's Conference while another ten members will be going to Harrisburg in April to advocate for continued PASSHE funding. Their election season is

approaching. They are making changes to their bylaws and constitutions to possibly change and add a proposed retention and recruitment committee to bring more students to advocate and be part of their organization.

Mr. Gavin Stone concluded his remarks.

6. Remarks by Dr. Kenneth S. Hawkinson, University President

Kutztown University was awarded a \$1.5 million grant to support its Regenerative Organic Agriculture track within its environmental science program in collaboration with the Rodale Institute. State Representative Mark Rozzi, a 1996 KU graduate, was a pivotal advocate in the university acquiring the grant from the Pennsylvania Department of Community and Economic Development. Funding will support student scholarships; internships; renovations to the university teaching greenhouse, adjacent to the newly built Nancy Jean Stump Seiger '54 Botanical Research Center; professional development for students, faculty and Rodale Institute employees; farming equipment and land care. There was a wonderful ceremony on February 29, with many attendees to celebrate the awarding of this grant.

2,094 students have been named to the Fall 2023 Dean's List at Kutztown University. To be eligible for the Dean's List, an undergraduate student must be registered for at least 12 credits and have a minimum grade point average of 3.60.

Kutztown University received more than \$150 thousand dollars in grants in recent weeks to help support the Campus Food Pantry, the Hunger Free Campus Program, the Women's Center for support of the It's On Us program, and the Visual Impairment Program

Dr. Stephen St. Onge began his tenure as vice president of Enrollment Management and Student Affairs at KU on February 12. Steve will oversee the comprehensive enrollment process including recruitment, admission, orientation and will contribute to retention efforts. He will also oversee areas related to student affairs and the quality of student life and success on campus. Steve comes to KU after nearly 10 years at California State Polytechnic University, Humboldt, Calif., where he served as the executive director for Auxiliary Operations since 2019. He also has 10 years of experience as a vice president at several universities.

Dr. Hawkinson mentioned that he recently attended an American Council of Education meeting in Washington D.C. with selected presidents from around the country and, accompanied by John McCallister, our grant writing consultants, met with our Congresswoman Madeleine Dean, and with representatives from Senator Fetterman's office, to discuss possible earmark funding for several projects. He also met on zoom with Senator Casey's staff.

On Tuesday, Dr. Hawkinson and his wife, Ann Marie, were pleased to join our national championship field hockey team as they were honored on the house floor at the State Capitol Building in Harrisburg. They were graciously hosted by our state representative, Rep. Jamie Barton – who introduced our athletes to numerous representatives to include the speaker of the house. Rep. Barton also hosted them for lunch where Rep. Mark Rossi, KU alum and former speaker of the house, also attended.

Not only did the team succeed on the field, but in the classroom. 17 players were named to the National Field Hockey Coaches Association Division II National Academic Squad last month. The program honors student-athletes who have achieved a cumulative grade-point

average of 3.5 or higher through the first semester of the 2023-2024 academic year. Congratulations once again to our NCAA Division II Golden Bear Field Hockey Team.

This month's video highlights Solomon Johnson, a senior sport management major from Philadelphia who is the student manager of KU's men's basketball team. Solomon plans to pursue a career in coaching, and appreciates the sense of family and community here at KU.

Dr. Ken Hawkinson concluded his remarks.
