1. Call to Order

The KU Presidential Search committee had its most recent meeting on November 26th where we reviewed the presidential profile after completing a day of very productive listening sessions with the various stakeholder groups. The final profile was sent to the campus community on Monday, and Storbeck, our search firm, has started active recruiting four our next president. 5. Remarks by Ms. Kyra Richards, Student Government Board President

We are grateful that their injuries were not serious and that all involved are okay, and I want to take a moment to remind everyone that kindness and compassion are some of the greatest abilities we hold as human beings.

Throughout the semester, we have sought student feedback on various issues, making sure that student concerns are valued, heard, and addressed. Our organization has strong momentum moving into the spring semester, and while we look forward to expanding on the items I've mentioned, we are looking forward to new opportunities as they arise. Additionally, we plan on working with our advisors on strengthening campus traditions and programs to give our students the full Golden Bear experience. In doing so, we aim to foster a lifelong love for our student community, extending beyond the time spent as students. We are, as always, extremely grateful for the support of peers, faculty, staff, and the Council of Trustees. We look forward to continuing our work for the student body in just a few short weeks."

6. Remarks by Dr. Kenneth S. Hawkinson, University President

"The Kutztown University football team had its first undefeated season in modern team history, finishing with an 11 and 0 record, and capturing the first back-to-back Pennsylvania State Athletic Conference titles in program history. The Golden Bears earned the top seed in Super Region 1 in the NCAA playoffs before suffering a heartbreaking overtime loss to Slippery Rock Thanksgiving weekend in the second round. Congratulations to AFCA regional coach of the year Jim Clements and the entire team for their continued success.

The Golden Bear field hockey team upset top ranked Shippensburg in the NCAA semi-finals in Gaffney, South Carolina, to advance to their second straight appearance in the Division II National Title game last month. The defending national champion Golden Bears lost to St. Anselm, 1-0, also in an overtime heartbreaker two days later in Gaffney. Congratulations to NFCHA Regional Head Coach of the Year Marci Scheuing and the field hockey team on another fantastic season.

Jason Graver was presented with the Kutztown University President's Medal last week for his volunteerism, commitment and dedication to preserving and celebrating the university's rich history. Jason graduated from Kutztown University in 1992 with a bachelor's degree in secondary education/political science and a master's degree in library science in 2018. In 2015, he became an invaluable alumni volunteer, serving on the history sub-committee of the KU Sesquicentennial Planning Committee. Jason has specialized in the collection of Kutztown University memorabilia and the history of the institution. In 2015, the history display in the Old Main Concourse opened to the public with the help of Graver's knowledge and collection. Since that time, Jason has worked closely with the gallery director and KU's Office of University Relations to refresh and upkeep a slightly toned-down display from the original. Congratulations to Jason, and if you haven't done so, please be sure to visit the Old Main Concourse to see Jason's ongoing work.

For the third year, Kutztown University has been awarded the Hunger-Free Campus grant to address food insecurity in students. The Hunger-Free grant awards \$60,000 to aid in expanding access to food options, creating awareness initiatives and upgrading facilities. At KU, the Bear Essentials Pantry, the on-campus food pantry, located in the McFarland Student Union and run by the Office of Student Involvement, provides non-perishable food items to students in need. The university also has a partnership with Friend, Inc., a local non-profit agency serving Northeastern Berks County, which provides a satellite food pantry adjacent to campus and critical support services to students in need.
