Kutztown University allows a person to appeal a parking violation believed to have been issued in error. This appeal form must be completed within seven (7) calendar days of the issuance of the citation. To have an appeal considered beyond the 7-day grace period, a customer must file the appeal and attend the next meeting of the University Traffic Bureau. (The UTB meets every twice a month on Thursdays at 11:00 AM while classes are in session. To verify the next meeting date, please call 484-646-4249.)
