A. Budget Update – Matt Delaney, VP of Administration and Finance

- PowerPoint available in the April Senate SharePoint folder.
- Graduate enrollment continues to rise, helping offset undergraduate decline.
- Slight uptick in deposits expected.
- Tuition held flat due to 6.5% increase in state appropriations.

- Personnel and healthcare costs rising (~17%).
- Balanced budget maintained for seven consecutive years.
- Significant increase in technology-related expenses.
- Proposed \$96 tech fee increase (40%) due to dwindling reserves.
 - o Fee supports staff, capital/operating expenses, and instructional tech.
 - o Concerns raised about possible cuts to library databases.

B. Strategic Enrollment Management (SEM) Plan – Steve St. Onge, VP of Enrollment Management and Student Affairs

- Full details in the April SharePoint folder.
- A 5-year SEM plan is underway with a revised June timeline.
- Focus areas include:
 - o New program development
 - Dual enrollment expansion
 - o Recruitment collaboration with faculty and athletics
 - o 4+1 and 4+2 program promotion
 - Strengthening first- and second-year experiences
 - o Sense of belonging, leaver study, and re-enrollment efforts
 - Accepted Students Day expected to break attendance records
