- 24.8% of KU students are registered with DSO.
- Most common accommodation: **distraction-free testing**.
- Continued increase in the number of students served.
- Autism Support Services now supports **60 students (up from 5 in 2016)**.

- “My Place” Resource Center serves **180 students**.
- DSO Testing Center in **205 Stratton**, staffed by three graduate assistants and supervised by the Assistant Director.
- Initiatives include sensory boxes, CEL partnerships, digital accessibility work, and more.
- Faculty may request a training session.
